

The High Court has passed the orders on 07.03.2019 in W.P.No.41256 of 2016 and batch that the petitioners are entitled to payment at the Rate of Rs.70,000/- (Rupees seventy thousand only) per month from the date of their re-admission to duty and the arrears, if any.

Therefore, in compliance of the orders of the High Court and in partial modification to the High Court's Notification read in the 5th cited, the High Court in exercise of the powers conferred by the Article 229 (1) and (2) of the Constitution of India r/w Rule 2 and 3 of A.P. High Court Special Service Rules for Court Managers, 2010, hereby fixed consolidated remuneration of Rs.70,000/- (Rupees seventy thousand only) per month, instead of Rs.50,000/- as mentioned in the High Court's Notification 5th read above, to all the Court Managers in the State of Telangana, who are re-admitted as per the High Court's Notification 5th read above, from the date of their re-admission.
